This data is passed to the Secretary by the members who consent to it being used for the purposes of running the Association. Member's data may appear in the publications of the BWMSBA (see details below).

The data is processed and stored by the Secretary. The database may be shared with Grassroots Systems Ltd, who provide the database software used by BWMSBA. Data is only communicated to third parties when it is required as part of the business of the Association.

Publications from BWMSBA include:

- An annual Flock Book records the sheep registered for that year, together with a list of current members, Flock names and numbers and details of their pedigree flocks. It also includes other information such as show results, often with photographs.
- A Newsletter which may include reports, articles, show results, photographs most of which are submitted by the members.
- Annual Reports and Accounts which are circulated to members prior to the AGM

A member's details will remain in the database for as long as their membership remains in force. In the year following termination of membership, personal details will be removed from the database although details of sheep registered by the member will remain in order to enable subsequent pedigree information to be processed. A member may request, in writing, that their personal data is not included in BWMSBA publications, though details of sheep registered by them will remain on the database.

A member's data will not be circulated outside of the membership without that member's permission.
